A. This Resolution will extend the Temporary Assignments to Higher Classification (TAHC) for Mr. Scott Wisniewski through October 4, 2014.

B. Because both TAHCs are into positions at a higher rate than Mr. Wisniewski made as a Fire Fighter, there is a net expenditure increase of approximately \$955 to have Mr. Wisniewski remain in the Assistant Fire Chief position through October 4, 2014.
