- A. The Office of the Comptroller is currently projecting a surplus of approximately \$20.0 million for 2024. This request transfers all but \$5.0 million of the remaining 2024 year-end surplus to the Debt Service Reserve. The remaining \$5.0 million of the surplus will be used as revenue in the 2026 Budget.
- B. Adoption of this resolution will increase the Debt Service Reserve by approximately \$15.00 million, depending on the final year-end surplus. This will potentially provide for \$15.0 million in revenue to offset future debt service costs. This figure is not final until the completion of the 2024 year-end audit.
- C. \$5.0 million of the surplus would be available for the 2026 budget. This is consistent with prior year-end actions with surpluses exceeding \$5.0 million and Wis. Stats. 59.60(6)(b)3.
- D. The exact amount of the 2024 surplus has not yet been finalized. The amounts cited are therefore approximate and based on data that is currently available.
