A. The Director of the Department of Health and Human Services (DHHS) is requesting authorization to execute 2015 Delinquency and Court Services Division (DCSD) purchase of service contracts with community vendors.

Approval of this request will allow the Director of DHHS to execute purchase of service contracts to continue provision of contracted Community Accountability/Service & Restitution Coordination, the Evening Reporting Center, the Saturday Alternative Sanctions Program, Re-Entry Coordination, Day Treatment, First Time Juvenile Offender, Prevention and After Care, Group Care, Level 2 In-Home Monitoring, Shelter Care and Targeted Monitoring services in DCSD for the period January 1, 2015 through December 31, 2015.

B. Total 2015 expenditures included in this request are \$8,317,443.

C. There is no tax levy impact associated with approval of this request in 2015 as funds sufficient to cover associated expenditures are included as part of DCSD's 2015 Budget.

D. This fiscal note assumes expenditures will not exceed the amounts authorized for these purchase of service contracts.
