The Director of Architecture, Engineering & Environmental Services is requesting authorization to have the County Conservationist apply for, accept and administer a staffing and cost share grant from DATCP to support Milwaukee County Land Conservation activities in 2027. The grant will be for approximately \$75,000 to support staff expenses.
 - B. This action will not affect the current budget year. The grant would be used to offset staffing costs of the Land Conservation Department in 2027.
 - C. This action will not affect the current budget year.
 - D. The grant amount was assumed based on past grants. An application will be filled out, if approved, and the Department of Agriculture, Trade and Consumer protection will determine the exact grant amount.
