- Subject: From the Superintendent, Community Reintegration Center requesting authorization to enter into a Professional Service Contract with Employ Milwaukee, Inc. for a Reentry Case Manager to provide reentry services to residents. The Reentry Case Manager will serve as a key support system for residents transitioning from incarceration back into the community, aiming to reduce recidivism and promote positive outcomes. The Contract term will be three (3) years, with two consecutive one-year renewal options, subject to the County's discretion beginning on January 1, 2025, to December 31, 2029.

POLICY

BACKGROUND

The current contract with Employ Milwaukee, Inc. to provide a Reentry Case Manager to provide reentry services to CRC residents expires on December 31, 2024.

On June 17, 2024, a Request for Proposal (RFP-2024-009 – Reentry Case Manager) was issued. The RFP closed on August 19, 2024. There was only one proposal submitted. An evaluation committee reviewed and scored the proposal and determined that Employ Milwaukee, Inc. had met the requirements of the CRC in both technical and cost. Milwaukee County, through the Joint Corrections Team, intends to enter into an agreement with Employ Milwaukee, Inc.

A few details of the new contract with Employ Milwaukee, Inc. are CRC will receive a Reentry Case Manager to provide reentry services to residents. The Reentry Case Manager will serve as a key support system for residents transitioning from incarceration back into the community, aiming to reduce recidivism and promote positive outcomes.

RECOMMENDATION

The Superintendent of the Community Reintegration Center respectfully submits this action item to request the authority to enter into three (3) years, with two consecutive one-year renewal options, subject to the County's discretion beginning on January 1, 2025, with Employ Milwaukee, Inc. to provide reentry services to residents to the Community Reintegration Center.
