- A. The Milwaukee County Transit System (MCTS) is requesting approval to finalize bus route changes due to the sale of the Downtown Transit Center.
- B. A nominal operating cost savings of 12 bus hours is anticipated in 2016 at a marginal operating cost of approximately \$70 for 88 weekdays. Totals \$73,920.
- C. The operating cost savings is favorable during a year in which transit is projecting an operating budget deficit. The savings were annualized and accounted for in the 2017 transit operating budget request.
