From the Chief Deputy, Office of the Sheriff, requesting authorization to retroactively accept funding on the I-43 URT, Milwaukee Project 2022 Traffic Mitigation contract (1228-22-93 contract no.2) with the Wisconsin Department of Transportation (WI-DOT) in the amount of \$346,454.94 for the period March 1, 2022, to December 31, 2022, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the State of Wisconsin Department of Transportation (WisDOT) has authorized funding for the Interstate 43 (I-43) Union Refrigerator Transit Company Milwaukee Project (the Project), with the Project area identified as interstates I-43 from the Milwaukee/Ozaukee County Line on the north, and the Mitchell Interchange on the south; and

WHEREAS, WisDOT has requested the implementation of a comprehensive and cost-effective transportation management plan, that will ensure the safety, accessibility, and mobility for the traveling public in the Project area; and

WHEREAS, WisDOT requires that the contract be executed for the period beginning March 1, 2022, through December 31, 2022, and additional contracts will be executed at the end of year 2022 for 2023 services; and

WHEREAS, the Office of the Sheriff (Sheriff) agrees to maintain a properly trained Deputy Sheriff patrol dedicated to the Project area for first and second shifts, seven days a week, beginning March 1, 2022, and ending December 31, 2022; and

WHEREAS, the Sheriff will bill WisDOT for Deputy Sheriff straight time, with overhead included at \$56.49 per-hour in 2022; and

WHEREAS, the Sheriff will bill WisDOT for Deputy Sheriff overtime at \$61.55 per-hour in 2022; and

WHEREAS, the Sheriff will provide a properly equipped enhanced construction patrol vehicle and squads, with the cost of fuel and maintenance to be billed at actual cost not-to-exceed \$45,850.50 in 2022; and

WHEREAS, the Committee on Finance, at its meeting of May 19, 2022, recommended adoption of File No. 22-521 (vote 7-0); now, therefore,

BE IT RESOLVED, the Office of the Sheriff is hereby retroactively authorized to accept the State of Wisconsin Department of Transportation Contract No. 2, State Project I.D. 1228-22-93, for March 1, 2022, through December 31, 2022, for the 2022 Traffic Mitigation Interstate 43 (I-43) Union Refrigerator Transit Company Milwaukee Project funding in the amount of \$346,454.94.
