

Innovation Grant Program Milwaukee County Applications

March 2026



Background

- The Innovation Grant Program (Wis. Stat. § 79.038) was created by 2023 Wisconsin Act 12, modified under 2025 Wisconsin Act 15, and administered by the Wisconsin Department of Revenue (DOR).
- A county, municipality, or tribe [Transferor] can apply for an innovation grant to support the **transfer of an allowable service** to another county, municipality, tribe, nonprofit organization, or private entity [Transferee].
- Purpose is to generate long-term cost savings for local governments by transferring services.

Eligibility

Eligible services include:

- Public safety, including law enforcement (not jails)
- Fire protection
- Emergency services
- Communications
- Public works
- Information technology
- Administration, including staffing, payroll, and human resources
- Economic development and tourism
- Public health
- Housing, planning, and zoning
- Parks and recreation



Grant Awards

- **Annual amount is equal to 25% of the total costs of providing the service** in the calendar year immediately preceding the transfer (baseline year).
- Number of annual payments received is based on the date of the first grant payment (earliest is 6/30/26) **and** the duration of the service transfer or contract years.
- To remain eligible each year, the total post-consolidation costs of the transferred service **cannot exceed 115%** of the total costs in the **baseline year**.



Service Transfer Identification Process

- Office of Strategy, Budget, & Performance staff:
 - Reviewed the administrative rule that was promulgated by DOR in spring of 2025 and amended in July 2025; and
 - Met with all administrative departments and elected offices that manage services that were eligible under the program to assess potential opportunities.



Milwaukee County Service Transfers

- Transfer of operations of Charles Allis Museum to the Charles Allis and Villa Terrace Museums, Inc **and** Transfer of operations of Villa Terrace Decorative Arts Museum to Villa Terrace Museum and Gardens, LTD.
 - 85% Milwaukee County; 15% Transferees (divided equally)
- Transfer of operations of Marcus Center for the Performing Arts to Marcus Center for the Performing Arts.
 - 85% Milwaukee County; 15% Transferee
