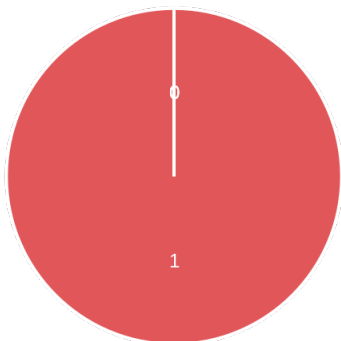

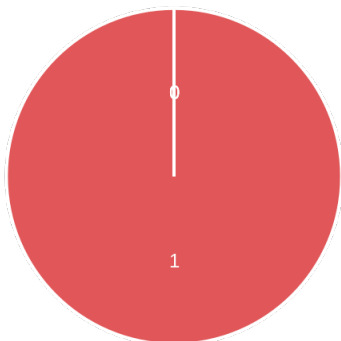

Hi CAMPAC reps and thanks for the time and expertise you bring to this group. I'd like to note that Milwaukee Arts Board does their grant application review in a public meeting format. I've learned a lot by listening to the reviewers.

Regarding social cohesion, I believe that most if not all arts experiences build social cohesion - just to different degrees. I agree that it's an important factor, but I also wonder if might be easier to measure something like the demographics of people served - and prioritize funding people from historically marginalized identities (People of the Global Majority, people with disabilities, low income individuals, etc). CAMPAC previously collected that data from us, and some orgs didn't provide any demographics, but many did. It's easy to see which groups are serving people from historically marginalized identities.
