A rate increase has been proposed by the State but is not yet effective. \$1,000,000 would cover the approximate cost of the increase based on the current average daily population. This increase would present significant financial risk if the average daily population increases. The \$500,000 earmark would help hedge against large increases in state juvenile correction rate charges and/or increases to the average daily population housed in the state facilities.

Amend Agency No. 800 - Department of Health and Human Services Housing Services Division by adding the following narrative language:

An appropriation of \$500,000 is provided to provide flexible resources to allow Housing staff to support unsheltered or housing insecure households that have exigent housing needs.

Amend the narrative for Agency No. 370 – Office of the Comptroller as follows:

The Comptroller, in collaboration with the Office of Corporation Counsel, shall submit a report to the County Board by the May 2025 meeting cycle regarding trust accounts. This report will detail the necessary requirements for County departments to establish and maintain trust accounts in compliance with Wisconsin State Statutes and Generally Accepted Accounting Principles (GAAP). The report shall also provide a standardized process for departments to follow, ensuring all necessary elements are thoroughly reviewed before seeking County Board approval for the creation of a trust account.

Amend the narrative for Agency No. 900 – Department of Parks, Recreation and Culture as follows:

#### Major Changes:

Milwaukee County Parks is proposing a trust fund for major maintenance expenditures contributing to the improvement and upkeep of McKinley Marina derived from a percentage of annual slip revenues. By approving this provision in the 2025 budget, the County Board authorizes the Office of the Comptroller, in conjunction with the Department of Parks, Recreation & Culture, to establish a trust for capital expenditures and major repairs related to McKinley Marina. The source of the trust fund shall be derived from a percentage of annual slip fee revenues, and it is estimated that \$39,340 will be deposited in the trust fund each year. The trust fund is estimated to be active for as long as McKinley Marina owned by Milwaukee County.

Rental rates and fees are minimally increased for various golf and foot golf rounds, pools, picnic areas, and pavilions, as well as facility rooms at horticulture and recreation center sites, dog exercise areas, special events, and sports permits. McKinley Marina slip fees increased. The 2025 budget authorizes the Office of the Comptroller in conjunction with the Department of Parks, Recreation & Culture, to establish a trust for major maintenance expenditures contributing to the improvement and upkeep of McKinley Marina. The source of the perpetual trust fund shall be derived from a percentage of slip fee revenues.

#### Summary of service level changes:

The source of the perpetual trust fund shall be derived from a percentage of slip fee revenues. If all required elements for establishing a trust account are met, the Department of Parks, Recreation, and Culture may submit a request to the County Board to create the trust. This request must also include a racial equity review, assessing the community benefits of the proposed trust.
