**MINUTES**

**I. CALL TO ORDER AND ROLL CALL**

**A. The 2025 Senior Leadership Program Applications are Open!** Applications will be accepted until April 4, 2025, and might be extended a few more days. - C. **2025 Wisconsin Aging Advocacy Network (WAAN) Aging Advocacy Day** is May 13, 2025 (an all-day event). Registration opens on Monday, March 10, 2025, and closes on April 25, 2025. Ms. Petersen encouraged Advocacy Committee members to attend this event, also she reminded the committee that the Senior Leadership participants will be attending the May Advocacy Committee meeting, so make sure they are all there. #### IV. LEGISLATIVE AND POLICE UPDATES

##### A. Federal Aging Policy

##### I. Federal Budget and Issues

- a. **Fiscal Year 2025 Budget Status Updates:** Last year, Congress passed a continuing resolution to fund the government until March 14, 2025. They now have one week to determine a budget for 2025. Congress has three options: they can create another bridge bill for a continuing resolution, pass a budget for fiscal year 2025 that would last until the end of September, or they could choose not to take any action, which would result in a government shutdown.
  
- b. **Medicaid Discussion:** At the February Commission on Aging (COA) meeting, the Commission on Aging approved adding support for Medicaid funding to the 2025 Advocacy Committee Policy Priorities. A letter was sent to Senator Baldwin and everyone in the Federal congressional delegation discussing the importance of funding Medicaid in 2026. Also, a few weeks ago the COA met with Senator Baldwin's office to discuss Medicaid.

##### II. Federal Regulations and Executive Orders

- a. **EO: Implementing the President's Department of Government Efficiency: Workforce optimization Initiative (Action Item):** Federal agencies are collaborating with DOGE efforts to implement targeted cuts to funding and programs and assess their impact on services. Additionally, Medicare is working with DOGE to identify efficiencies within its operations. Both the Chair of the COA and Chair Peters are committed to reaching out to legislators to discuss how these cuts will affect Social Security and their implications for the population of Milwaukee County and the State of Wisconsin.

MOTION: To have staff (Emily Petersen) draft a letter to legislators about their concerns with Social Security.

## **B. State Legislative Issues**

### **I. State Budget & Legislation**

- a. Governor Evers budget introduction on February 18, 2025:** Ms. Petersen will email the Advocacy Committee a copy of Governor Evers's budget released **on February 18, 2025**. She will also distribute via email a comparison document from WAAN outlining which of the AAA's aging programs and services were funded in the Governor's budget.

**Joint Finance Committee Budget Hearings:** The next step in the state budget process is the Joint Finance Committee budget hearings. They have yet to be announced but will be circulated when they are. It is important for members to attend at least one of the hearings to share aging budget priorities with legislators.

- b. Advocating for Evidence-Based Wellness Programs, Jennifer Lefeber, Milwaukee County Aging EBPP Coordinator:** Jennifer Lefeber, DHHS, ADS, Health and Wellness Programs Coordinator, delivered a PowerPoint presentation that outlined the various evidence-based programs offered by the Area Agency on Aging. These programs included disease self-management initiatives, chronic conditions, physical activity, and falls prevention. She also shared information about the current funding sources for the Evidence-Based Promotion Programs (EBPP), which are supported by the Older Americans Act, ARPA funding for Title IIID, and mini-grants from the Wisconsin Institute for Healthy Aging (WIHA). Finally, she addressed the challenges associated with financing and implementing these programs.
