From the Director, Department of Transportation, requesting to amend the Milwaukee County Code of General Ordinances Chapter 71 Section 71.30 to change the speed limit from forty (40) miles per hour to thirty-five (35) miles per hour on South 13th Street (CTH V) from West College Avenue (CTH ZZ) to West Puetz Road, by recommending adoption of the following:

A RESOLUTION/ORDINANCE

WHEREAS, Chapter 71 Section 71.30 of the Milwaukee County Ordinances establishes speed limits on County highways pursuant to the authority established by Chapter 349.11 of the Wisconsin State Statutes; and

WHEREAS, it has been determined by the Milwaukee County Department of Transportation that reducing the speed limit from forty (40) miles per hour to thirty-five (35) miles per hour on S. 13th St. (CTH V) from W. College Ave. (CTH ZZ) to W. Puetz Rd. would be appropriate to establish a safe and uniform speed limit in this corridor; and

WHEREAS, the proposed thirty-five (35) miles per hour speed limit is better suited than the existing speed limit in terms of the design speed of the proposed roadway, roadside friction, speed enforcement efforts, and overall traffic safety and service aspects of the facility and adjacent developments; and

WHEREAS, the Cities of Milwaukee and Oak Creek both responded with support of the speed limit reduction; and

WHEREAS, the Committee on Transportation and Transit, at its meeting of March 11, 2024, recommended adoption of File No. 24-301 (vote 5-0); now, therefore,

BE IT RESOLVED, that the Milwaukee County Board of Supervisors hereby amends Chapter 71 Section 71.30 of the Milwaukee County Code of General Ordinances by adopting the following:

AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 71.30 South 13th Street (CTH ‘V’) is hereby amended as follows:

71.30 – South 13th Street (CTH ‘V’)

- (a) From the south line of West College Avenue (CTH ‘ZZ’) to the Milwaukee-Racine County line. Maximum speed forty (40) miles per hour. north line of West Puetz Road. Maximum speed thirty-five (35) miles per hour.
