However, to ensure that the Milwaukee County Board of Supervisors is aware of any settlements, the OCC reports on a monthly basis the following information:

- 1. WCMIC-controlled litigation settlements that exceed \$500.00.<sup>1</sup>
- 2. WCMIC-controlled claim resolutions.
- 3. Resolution of legal claims and litigation covered under other County insurance policies.
- 4. Resolution of legal claims and litigation in which the County is the party-plaintiff (or counterclaim plaintiff) whether Board approval is or is not required pursuant to Wisconsin law.
