## REQUEST

The Executive Director of Milwaukee County Parks seeking authorization to submit to the grant programs for the Land and Water Conservation Funding Program, and, if applicable, to accept a related grant award.

### BACKGROUND

Milwaukee County Parks owns and maintains Moss Universal Park (formerly Wisconsin Avenue Park) at 10300 Wisconsin Ave, which is a 17.9-acre neighborhood park in Wauwatosa. This the site has recently been supported through project commitments by The Ability Center (TAC). TAC is a 501(c)(3) nonprofit and works towards a goal to provide a higher quality of life for people of all abilities by transforming greater Milwaukee into the most universally inclusive recreation destination in the world.

Parks has entered into a 25-year lease arrangement with TAC that acknowledges their plans for a fully accessible park, to be achieved through 2 phases of construction. The first phase includes upgrades to the park clubhouse, accessible restrooms, a universal field, improved baseball and softball fields, accessible playground spaces, and a new and expanded parking lot. Phase two of the project proposes accessible paths, fitness stations, activity areas, an inclusive challenge course, and sensory destinations. The total cost of the project is estimated at \$10 million, which TAC is providing through its fundraising, with no funding required from Milwaukee County.

While evaluating different funding opportunities, the Federal Land and Water Conservation Fund (LWCF) grant program was identified as a potential resource for this universal park project. The Wisconsin Department of Natural Resources (DNR) administers the Federal Land and Water Conservation Fund (LWCF) program. Funds received by the DNR for this program are split between DNR projects and grants to local governments for outdoor recreation activities. The LWCF encourages the creation and interpretation of high-quality outdoor recreational opportunities, which matches with the existing project goals.

Milwaukee County Parks staff have worked in collaboration with TAC to prepare an application for LWCF funds in spring of 2024. Because TAC is providing all necessary funding match, there is no financial obligation from the County for the grant application, with the exception of staff time.

Permission from the Milwaukee County Board is requested to authorize Milwaukee County Parks, Office of the Comptroller, Department of Administrative Services, Corporation Counsel, Risk Management, Office of Economic Inclusion, Office of the County Executive or any other department necessary to take all actions required for the purpose of accepting and administering a grant, if awarded.
