SUBJECT: Request from the Office of Emergency Management (OEM) to abolish ten (10.0) Hourly Special Events Paramedics and create ten (10.0) Hourly Emergency Medical Services (EMS) Lieutenants to provide adequate staffing levels for medical operations of the Community Oriented Regional EMS (CORE) Team

The EMS Lieutenant positions provide emergency medical coverage to contracted venues within Milwaukee County for onsite Paramedic response and these services are fully funded by the contracted venues. OEM will utilize its existing hourly budget to fund these positions and will be reimbursed by the contracted venues.
- C. There is no new funding being requested for the creation of the ten Hourly EMS Lieutenant positions. OEM will utilize its existing hourly budget to fund these positions and will be reimbursed by the contracted venues.
