

The Department of Pre-Trial Services has requested and received permission from the U.S. Department of Justice to extend the 2013 Adult Drug Court Grant. The grant was scheduled to conclude on 9/30/2015, however, there were remaining funds totaling \$57,611.18. Permission for the no cost extension was granted on 9/1/2015. The new scheduled ending date for the grant is now 12/31/2015. There will be no fiscal impact in regards to extending the grant as the expenditures and resulting revenue were including in the 2015 budget.
