DAS-FMD requests to create 1.0 FTE Principal Facilities Ca-, Pay Grade 38M. The Principal Facilities Ca- position was not included in the adopted 2024 operating budget because of a pending retirement that was anticipated in early 2024, but that retirement is being rescheduled at the request of the current employee.

BACKGROUND

DAS- Facilities Management Division is responsible for strategic planning, managing and delivering the majority of the projects within the County's annual capital program. We are undergoing a transformational reorganization to improve all aspects of capital planning, project delivery and customer service.

Within DAS-Facilities Management Division, the Facilities Condition Assessment Program (FCAP) provides building systems condition assessment services for County-owned facilities and administers a software-based asset management system that is a repository for all the building condition data and building system deficiencies. This database provides the basis for major maintenance and capital improvement project requests.

The current County employee in the Principal Facilities Ca- role had indicated a retirement date in early 2024. The adopted 2024 operating budget did not include the Principal Facilities Ca- position. The current Principal Facilities Ca- has requested to reschedule retirement to June 28, 2024.
