BE IT FURTHER RESOLVED, DPRC, the Department of Administrative Services, and the Office of the Comptroller are authorized to execute any contracts and/or documents necessary to disburse funding to the awarded organizations.; and

BE IT FURTHER RESOLVED, that the current distribution model shall be deemed null and void upon completion of the 2025 grant allocations; and

BE IT FURTHER RESOLVED, DPRC is requested to collaborate with CAMPAC to develop a new funding formula, in consultation with the United Performing Arts Fund (UPAF), and

BE IT FURTHER RESOLVED, that the new distribution formula shall take into account the track record and performance of each applicant, the size of each arts organization, and its inclusiveness in serving the residents of Milwaukee County; and

BE IT FURTHER RESOLVED, that CAMPAC and DPRC are requested to present their recommendations for revised grant criteria to the County Board by the June 2026 meeting cycle for review and approval.
