

3 A report from the Executive Director, Department of Health and Human Services,  
4 requesting authorization to execute 2026 fee-for-service contracts with community  
5 vendors for Children, Youth and Family Services (CYFS). Community Youth and Family  
6 Aids in the amount of \$41,990,627, by recommending adoption of the following:

8 **A RESOLUTION**

10 WHEREAS, per Section 59.52(31)(c), Wisconsin State Statutes (State Statutes),  
11 the Director, Department of Health and Human Services (DHHS), is requesting  
12 authorization to execute 2026 fee-for-service agreements with a variety of community  
13 vendors; and  
14

15 WHEREAS, Children, Youth, and Family Services (CYFS), DHHS, is responsible  
16 for supporting a social service delivery system for children, youth, and families in  
17 Milwaukee County; and  
18

19 WHEREAS, DHHS partners with community vendors to provide out-of-home  
20 placements, including group homes and residential treatment centers (RTC), as well as  
21 clinical services for youth, as mandated by court orders and to support the youth justice  
22 continuum of care; and  
23

24 WHEREAS, while the majority of 2026 CYFS, DHHS, fee-for-service contracts  
25 were identified and approved through the 2026 Adopted Budget process, the contracts  
26 presented herein were not included in that process and therefore require separate  
27 approval in this cycle; and  
28

29 WHEREAS, funding for these fee-for-service contracts is included in the 2026  
30 CYFS, DHHS, budget; and  
31

32 WHEREAS, the Committee on Health Equity, Human Needs, and Strategic  
33 Planning, at its meeting of December 4, 2025, considered File No. 25-752 for  
34 informational purposes only, per Section 59.52(31)(d), State Statutes; and

36 WHEREAS, the Committee on Finance, at its meeting of December 11, 2025,  
37 recommended adoption of File No. 25-752 (vote 6-0); now, therefore,

39 BE IT RESOLVED, the Director, Department of Health and Human Services, or  
40 her designee, is hereby authorized to enter into fee-for-service contracts for a not-to-  
41 exceed total of \$750,000, for the period of January 1, 2026, through December 31,  
42 2026, with the agencies and in the amounts listed below:
