

## **Overall Sentiment**







\* Read the City of Milwaukee's "GrowingMKE" plan and take whatever steps necessary to support its approval on a county level;

\* Lean on municipalities within Milwaukee County to liberalize their zoning policies, remove building height restrictions, and stop caving to the interests of unrepresentative NIMBYs (whether they be wealthy homeowners or misguided activists);

\* Advocate for the removal of any and all unnecessary bureaucratic hoops to be jumped through on the path to development, including excessive community input sessions (which seem designed to cater exclusively to NIMBYs) and design review submissions;

\* Recognize that the one thing which will meaningfully decrease the cost of rent is to massively increase the quantity of multi-family homes being built throughout Milwaukee County — even and especially if they are market-rate rather than subsidized.
