 - A. The CRC is requesting to abolish a vacant 1.0 FTE Plumber position, and create 1.0 FTE Plumber Supervisor position, consistent with operational needs of the Department.
 - B. Approval of this resolutions will have a direct County fiscal impact of \$5,768, with a cost of \$10,712 in 2024.
 - C. Approval of this resolution has no budgetary impact due to a salary adjustment already added to the 2023 budget of \$38,292.
 - D. The assumption that was made is that the position will be created and hired by June 12, 2023.
