A. The Office on African American Affairs and The Y.W.C.A. have revised the initial scope of work and is seeking to increase the professional services agreement by \$58,000, resulting in the new total of \$143,000.

B. In 2019, the total contract cost will be \$143,000. This cost is inclusive of the normalization sessions/activities that will be offered Countywide, the change in Y.W.C.A staff members; adding one more staff member and removing 2 who are no longer employed with the Y.W.C.A. Also incorporates the transition of a model, to allow selected County staff to become 'trained' in racial equity facilitation to encourage training sustainability.

C. In 2019, \$143,000., of the contract will be covered from the Office on African American Affairs' 2019 operating budget.

D. Approval of this request will result in the agreement being increased by \$58,000 with a new agreement total of \$143,000.
