A. Parks is requesting to create 3 FTE Park Maintenance Worker positions.

B. The proposed pay grade of NR18 has a top pay of \$66,393.60. The requested 3 FTE Park Maintenance Worker positions will be filled at \$47,841 including social security at the start of the second quarter resulting in salary savings. The impact on 2026 is an added expense of \$94,275.

C. The budgetary impact in 2026 is \$94,275 which will be absorbed in the 2026 Parks Budget.

D. The Park Maintenance Worker positions are expected to be filled at the start of the second quarter.
