Subject: **Approval of the 2020 Milwaukee County Cultural, Artistic, and Musical Programming Advisory Council Allocation Recommendations – Action**

Issue

The Department of Parks, Recreation and Culture (DPRC) annually presents funding recommendations on behalf of the Milwaukee County Cultural, Artistic, and Musical Programming Advisory Council (CAMPAC) for approval.

Background

Since 1986, the County has utilized the services of CAMPAC to allocate Milwaukee County arts funds to various local art agencies, individuals, and organizations. The original agreement, as adopted under County Board Resolution No. 86-466 and 86-463, and as modified by County Board Resolution No. 87-732, has been extended on a year-to-year basis since 1986.

The 2020 adopted County Budget provided \$407,825.00 in funding for the CAMPAC initiative. Attached are the recommendations from CAMPAC, which outline the plan for distribution of the 2020 funds. The allocations were approved by CAMPAC at its January 29th, 2020 board meeting. An error in calculation was discovered after CAMPAC approval resulting in an incorrect award for Present Music. The attached allocations are corrected and now within budget.

A substantive change from previous years CAMPAC allocations is the inclusion of funding for Concerts in the Parks through 2020 adopted budget amendment 1C002.




Recommendation
