There are no capital projects in Milwaukee County Parks' 5-year Capital Improvement Plan pertaining to the Dale Creek property and there are no anticipated operating expenses as this property has been the responsibility of the Village of Greendale since 1995. If this transaction is not completed, the Dale Creek property could become a new responsibility for Milwaukee County Parks and would add significant capital and operating needs to the County.
