Re: Unqualified Support for Appointing Scott Brown as Milwaukee County Corporation Counsel

Dear Chairperson Nicholson and Supervisor Bielinski:

It has been my privilege to serve the Wisconsin Counties Association and counties across the state in my legal practice for over 29 years. In that time, I have enjoyed the opportunity to work with and for Milwaukee County and the Office of Milwaukee County Corporation Counsel on a variety of legal issues impacting Milwaukee County. Based upon my experience with corporation counsel around the State, as well as former Milwaukee County Corporation Counsel, I am confident that Scott Brown is both capable and qualified to lead the Office of Corporation Counsel.

My first opportunity to work with Scott arose when he held the position of Assistant Corporation Counsel and the County joined with 70 other counties across the State in seeking to hold the perpetrators of the opioid epidemic responsible for their actions in the most complex civil litigation in the history of our nation. The Wisconsin effort was complicated and multi-faceted requiring not only a traditional litigation strategy, but also a legislative strategy to ensure Wisconsin counties were appropriately compensated in the event settlement revenues came to fruition. Scott assumed a leadership role in working with me and WCA on the legislative effort. I was immediately impressed by Scott's ability to quickly grasp complicated concepts and articulate positions that benefited Milwaukee County and counties across the State.
