A. Section 301.031 of the Wisconsin Statutes requires counties to execute an annual contract with the State Department of Children and Families (DCF) for the “Community Youth and Family Aids Program.” This program provides State funding for County services to justice-involved youth as mandated by State and/or Federal law. The Director, Department of Health and Human Services (DHHS), is requesting authorization to enter into a 2025 contract with the State for the provision of youth justice services mandated by State law.

B. The 2025 contract provides \$41,990,627 in Youth Aids funding, which is \$248,935 more than budgeted in 2025. This amount will be absorbed in the CYFS 2025 Budget.

C. Similar to previous years, the 2025 contract for Community Youth and Family Aids Program requires a match amount of \$511,882 which is included in the 2025 CYFS Budget in agency 800. In addition, the contract requires a match of \$4,281,792 for Title IV-E administered by the Combined Court Related Operations and this match is included in the budget for agency 200 – Combined Court related Operations.

D. No further assumptions are made. The revenue amount is reflected in the State contract.
