A report from the Director, Department of Health and Human Services, requesting authorization to execute non-professional service contracts with a network of caterers supporting the Senior Nutrition Programs from January 1, 2025, through December 31, 2025 at a cost of \$2,862,754, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, Aging and Disabilities Services (ADS), Department of Health and Human Services (DHHS), within Milwaukee County (the County) hosts the local Area Agency on Aging, which oversees nutritional programs for older adults, which are funded through Title III-C, Older Americans Act; and

WHEREAS, the County’s nutritional programs for older adults are known as the Senior Dining Program, and include three methods:

- Congregate dining within the network of Senior Centers
- Home delivered meals also known as Meals on Wheels
- Dine-Out Program hosted by restaurants owned by local residents of color

; and

WHEREAS, consistent with Section 59.52(31)(c), Wisconsin State Statutes, ADS, DHHS, must bring contracts with a value or aggregate value of \$300,000 or more to the Milwaukee County Board of Supervisors for authorization; and

WHEREAS, the Committee on Finance, at its meeting of December 12, 2024, recommended adoption of File No. 24-894 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Director, Department of Health and Human Services, or her designee, to execute Non-Professional Service contracts with caterers that support the Senior Nutrition Program from January 1, 2025, through December 31, 2025, with the providers and for the terms as listed below at a cost not-to-exceed \$2,862,754:
