POLICY

BACKGROUND

The Department of Human Resources in accordance with State Statute 111.70 and Milwaukee County General Ordinances 79 & 80 are providing the following documents to the Committee for review:

- 1) The Amended Memorandum of Agreement (MOA) between the County and the Association of Milwaukee County Attorneys (AMCA);
- 2) A notification from the Association of Milwaukee County Attorneys (AMCA) the MOA was ratified by the membership;
- 3) A draft Resolution approving the MOA;
- 4) A fiscal note that has been prepared by the Office of the Comptroller.

FISCAL EFFECT

The Memorandum of Agreement terminates on December 31, 2023 and provides a two percent increase in wages of bargaining unit employees, effective Pay Period 8, 2023 (April 2, 2023).

TERMS

This Agreement is to take effect on January 1, 2023. Unless otherwise modified or extended by mutual agreement of the parties, this Agreement shall expire on December 31, 2023.
