A. The goal of the airport is to treat similarly situated ground transportation providers equally. A review of current fees identified some disparities in fee structure. An amendment to Milwaukee County Ordinances Chapter 4 on Airport Ground Transportation Fees is being recommended to eliminate the inconsistencies.


B. Anticipated revenue from ground transportation pick-up and trip fees are expected to increase by \$369,000 per year.

C. Based on a proposed effective date of September 1, 2016 it is anticipated that revenue would increase by \$123,000 for 2016. The revenue will be used to offset costs of ground transportation construction, management, safety and security.

D. It was assumed that taxi, TNC, limo, shuttle busses, and scheduled buses would continue with the same frequency at the airport.
