 - A. Milwaukee County Parks requests permission to transfer funds out of the contingency account in WP037201-McKinley Park Flushing Channel. Amendment 78 quarantined the funds until a report could be submitted evaluating alternatives.
 - B. There are no additional direct costs associated with the request. Funding has been appropriated in the 2023 capital budget. Additional funding will be requested in subsequent budget years for remaining work not covered by the 2023 budget.
 - C. The appropriate budgeted amount of funding to execute the project was estimated to be \$5,573,376. Only \$2,895,441 or 52% was appropriated in the 2023 budget. Additional funding will be requested in subsequent budget years. Reducing the necessary appropriation may require another mobilization increasing the total project cost. Staff will attempt to minimize additional costs of bidding and mobilizing construction twice.
 - D. No assumptions were utilized in this analysis.
