**1.** Presentation by Aaron Hertzberg, Director of the Department of Administrative Services, Milwaukee County (Informational Only)

Aaron Hertzberg, Director of the Department of Administrative Services for Milwaukee County, Presented to the youth commission. Mr. Hertzberg began his presentation by introducing himself. He is a native of Racine and attend Park high school. Mr. Hertzberg talked about his career path, he worked in non-profit and Government leadership, Community and Economic Development. He has spent the last 7 years with Milwaukee County. Me. Hertzberg spoke about the county budget as a refresher for the commissioners.
