

 - A. Approval of this resolution will state Milwaukee County's support of restoring the composition of the MATC District Board to the previous structure that all other Wisconsin Technical College System district boards adhere to. The MATC District Board Appointment Committee process is recommended to be structured similarly to the appointment process for the MATC District School Board Presidents. The Milwaukee County Executive is requested to appoint qualified county residents to the District Board, use legal means to fight racial disenfranchisement in the MATC District Board appointment process, and work with the County and the State Legislature to restore the previous board appointment process for MATC, prior to enactment of Senate Bill 275.
 - B. Approval of this resolution will not require an expenditure of funds, but will require existing staff time to communicate its contents to the appropriate individuals.
 - C. No budgetary impacts are associated with this proposed action.
