From the Director, Department of Transportation, Relative to an Amendment to Chapter 69.02 of the General Ordinances Concerning Parking on South 92nd Street (CTH N), by recommending adoption of the following:

A RESOLUTION/ORDINANCE

WHEREAS, Section 69.02, Milwaukee County Code of General Ordinances, establishes parking regulations on County Trunk Highways (CTH), pursuant to the authority established by Section 349.13, Wisconsin State Statutes; and

WHEREAS, the Department of Transportation was performing a rehabilitation project on South 92nd Street (CTH N); and

WHEREAS, the paved shoulder of South 92nd Street (CTH N) is not wide enough to park on; and

WHEREAS, it has been determined that there is an existing “No Parking Zone” on the west side of South 92nd Street (CTH N) that is not in the ordinances, and needs to be codified; and

WHEREAS, the Committee on Transportation, Public Works, and Transit, at its meeting of March 11, 2020, recommended adoption of File No. 20-217 (vote 4-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby amends Section 69.02 of the Milwaukee County Code of General Ordinances, by adopting the following:

AN ORDINANCE

The County Board of Supervisors of the County of Milwaukee does ordain as follows:

SECTION 1. Section 69.02 of the General Ordinances of Milwaukee County is hereby amended as follows:

69.02. – Parking prohibited in designated areas.

No person shall stop or leave any vehicle standing in any of the following places, except temporarily, for the purpose of and while actually engaged in loading or unloading or in receiving or discharging passengers and while the vehicle is attended by a licensed operator:

- (1) College Avenue (C.T.H. 'ZZ')
 - (a) Between the limits of South 20th Street and South 27th Street.
 - (b) On the south side, from a point four hundred fifty (450) feet east of South 35th Street to the limits of South 27th Street.
- (2) South 76th Street (C.T.H. 'U')
 - (a) Between the limits of West Grange Avenue and West Layton Avenue.
 - (b) Between the limits of West Ryan Road and a point three-fourths ($\frac{3}{4}$) of a mile north of Ryan Road.
 - (c) Along the west side of South 76th Street (C.T.H. U) from a point six hundred fifty (650) feet south of the south line of West Ryan Road to a point nine hundred seventy-five (975) feet south of the south line of West Ryan Road.
 - (d) Along the west side of South 76th Street (C.T.H. U) from a point one thousand seventy-five (1,075) feet south of the south line of West Ryan Road to a point one thousand two hundred (1,200) feet south of the south line of West Ryan Road.
- (3) Good Hope Road (C.T.H. 'PP')
 - (a) Between the limits of North Port Washington Road and North Pierron Road.
- (4) South 68th Street (C.T.H. 'A')
 - (a) Between the limits of West Ryan Road and a point three-fourths ($\frac{3}{4}$) of a mile north of Ryan Road.
- (5) West Beloit Road (C.T.H. 'T')
 - (a) North side of the road from the intersection of South 108th Street (S.T.H. 100) to a point five hundred seventy (570) feet east of South 108th Street.
- (6) West Layton Avenue (C.T.H. 'Y')
 - (a) From the limits of South 60th Street to a point eight hundred twenty-five (825) feet east of South 60th Street.
- (7) South 92nd Street (C.T.H. 'N')
 - (a) On the west side of the street from the limits of West Howard Avenue to the limits of West Waterford Avenue.

SECTION 2. The provisions of this ordinance shall be effective upon passage and publication.
