A. Authorization to grant a permanent easement to WE Energies to allow for the replacement of a gas main in and across certain portions of parkland in the City of South Milwaukee by Manitoba Avenue and Oak Creek Parkway

B. Revenue of approximately \$4,480 (approximate because it will be based on final easement square footage at a rate of \$0.64/square foot) will be realized based on similar easement requests/offers and comparable land values. Parks has determined that this is fair compensation for the permanent easement with an acreage of approximately 0.1607 acre. Staff time will be required for review of the Right of Entry application, but this review time will be compensated by the application fee.

C. The revenue for the easement will help meet revenue targets for the budget year.
