SUBJECT: County Executive Office Report

1. Affordable Care Act (ACA) Marketplace Open Enrollment & Call to Extend Tax Credits

- County Executive Crowley highlighted the start of the ACA Marketplace open enrollment period at the Marcia P. Coggs Health & Human Services Center.
- Enrollment Deadline: January 15, 2026.
- In 2025, **51,420 Milwaukee County residents** enrolled in Marketplace coverage (up from 26,690 in 2023).
- The County Executive urged Congress to **extend enhanced ACA premium tax credits**, warning that expiration would significantly raise premiums for many residents.
- Enrollment assistance is available through Covering Wisconsin and the Milwaukee Enrollment Network.

2. Lead Hazard Reduction – Countywide Lead Remediation Program

- Milwaukee County launched a **Lead Remediation Program** aimed at eliminating lead-based paint hazards in suburban homes.
- Funded by a \$7.75 million HUD grant, with additional support from CDBG funds.
- Goal: Remediate lead hazards in **up to 200 low-income**, **owner-occupied homes** located outside the City of Milwaukee.
- Assistance includes: lead inspections, project management, no-interest loans, and construction services by licensed lead-safe contractors.



• Eligible households must meet income guidelines, be current on property taxes, and have at least one child with an elevated blood lead level.

3. FoodShare Benefits – Response to Trump Administration's Attempt to Rescind Support

- The County Executive issued a statement opposing federal action to **rescind FoodShare benefits**, warning of severe impacts on low-income seniors, individuals with disabilities, and children.
- The action threatens tens of thousands of Milwaukee County residents who rely on FoodShare for basic nutrition.
- Crowley emphasized the importance of stable federal nutrition programs to county public health, equity goals, and economic stability.

4. 2026 Milwaukee County Budget Approval

- County Executive Crowley, County Board Chair Nicholson, and Chairwoman Bovell approved the **2026 Milwaukee County Budget**.
- Budget Priorities:
- o Advancing health equity and racial equity.
- o Supporting accessible transportation systems.
- o Strengthening public health and human services infrastructure.
- The budget continues stabilizing County finances following pandemic-era fiscal stress.

5. County Executive Crowley Receives Goodwill New Lives Individual IMPACT Award

- County Executive Crowley was honored with Goodwill Industries' **New Lives Individual IMPACT Award**.
- Award recognizes leadership in supporting employment pathways, economic mobility, and



second-chance opportunities.

• Crowley highlighted the importance of partnerships between government, nonprofits, and employers in building community resilience.
