



The audit showed some truly alarming issues in the jail, particularly with how those with mental health issues or experiencing suicidal thoughts are treated.


People are continuing to die in the jail since this audit, and serious accountability measures need to be put into place to follow any plans for corrective action.



I believe that it is difficult, if not practically impossible, to ensure that facial recognition technology does not prevent human rights or First Amendment rights violations. With that said, I still support this agenda resolution because if the county is moving forward with facial recognition technology regardless, I am in favor of ensuring to the full extent possible that this technology does not suppress free speech or limit community members' rights, and that there is community control over how police surveillance is conducted.

In addition, I am outraged that people are still dying in the Milwaukee County Jail. Jail should not be a death sentence. The Jail Audit was only a first step, but I have not seen enough actual change after the results of the audit came out. I applaud the supervisors for considering an oversight board for the Sheriff, and hope it has powers to cut the budget, change policy, and hire and fire.

It is abundantly clear that a civilian accountability council is sorely needed - and not a hand selected board like Sheriff Ball has suggested. This council should have elected members, input from communities most impacted by the jail, including formerly and currently incarcerated members, and it should have real power to make changes.

It is crucial that this body have real power, and that it represent the will and interests of the broader community. A hand selected board with no authority, like what Sheriff Ball has suggested, is simply not worth pursuing, as it would exist to provide cover for existing issues rather than address them head on.

This is something that is worth doing right. A real community accountability council should be established as soon as possible to follow corrective action plans from the audit, and to come up with solutions to prevent further harm and in custody deaths.
