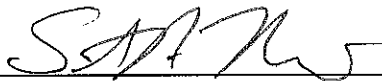

Approval of the request to create 2.0 FTE in the District Attorney's office would have a new annual cost increase of \$48,343. Assuming the positions are filled with 4 pay periods remaining in 2016, the current year cost increase by \$2,496 which is absorbed in the District Attorney's 2016 Budget. Subsequent years increase net annual costs by \$48,343. These figures include salary, social security, employee health care, employee pension, and training. The costs assume an 80 percent match by the VOCA grant dollars.
