REQUEST

Milwaukee County Parks providing and informational report on the 2023 departmental capital request.

POLICY

The Office of Strategy, Performance and Budget sets the parameters for capital budget submission in Milwaukee County. Capital budgets for 2023 were due on May 20, 2022. The Capital Improvement Committee will be reviewing departmental requests per Chapter 36 of the Milwaukee County Code of General Ordinances. Policies enacted in the 1995 adopted budget and File# 03-263 set parameters for cash and bond spending in Milwaukee County.

BACKGROUND

Annually departments are requested to provide capital projects to be considered for inclusion in the following year capital budget. Milwaukee County Parks submitted a request for funding forty-three projects totaling over \$45.2 million in 2023.

At the June 10, 2022, meeting of the Capital Improvements Committee, File # 22-734 was presented which outlined the available financing and the sum of preliminary county requests. The available 2023 bond financing is estimated at \$45.8 million, and the available cash financing is estimated at \$11.4 million leaving funding shortfalls of \$55.9 million and \$27.8 million in each respective category.
