Purchase of Service Contract extension with Aramark Correctional Services LLC to extend the term for commissary, trust accounting, and kiosk services, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the current commissary and accounting services contract with Aramark Correctional Services, LLC (Aramark) expires on December 31, 2024; and

WHEREAS, a Request for Proposals (RFP) was issued on April 17, 2015, and Aramark was selected as the provider; and

WHEREAS, on December 23, 2015, the Milwaukee County Board of Supervisors (County Board) adopted File No. 15-720, which granted the Community Reintegration Center (CRC), the authority to enter into a contract with Aramark for the provision of commissary services at both the CRC and Criminal Justice Facility (CJF); and

WHEREAS, the terms of the contract approved by the County Board in adopted File No.15-720 was from January 1, 2016, through December 31, 2018, with two additional one-year extensions (2019 through 2020), subject to County Board approval; and

WHEREAS, the County Board approved an additional one-year extension in adopted File No. 19-362, which expired on December 31, 2021; and

WHEREAS, the County Board approved an additional one-year extension in adopted File No. 21-420, which expired on December 31, 2022; and

WHEREAS, the County Board approved an additional one-year extension in adopted File No. 22-1100, which expired on December 31, 2023; and

WHEREAS, the County Board approved an additional one-year extension in adopted File No. 23-944, which expires on December 31, 2024; and

WHEREAS, on September 25, 2023, RFP-2023-009 (the RFP) was issued for Correctional Commissary and Trust Account Services, and closed on December 15, 2023; and

WHEREAS, on February 5, 2024, the RFP was reissued (RFP-2024-001) for Correctional Commissary and Trust Account Services, and closed on March 22, 2024; and

45 WHEREAS, Aramark has agreed to a new, six-month contract extension, with  
46 the same provisions, to help provide continuity in commissary services to allow the RFP  
47 process to conclude, and to provide time for the negotiation of a new contract, and the  
48 transition phase; and

50 WHEREAS, the Committee on Finance, at its meeting of December 12, 2024,  
51 recommended adoption of File No. 24-882 (vote 7-0); now, therefore,

53 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby  
54 authorizes the Superintendent, Community Reintegration Center (CRC), to enter into a  
55 new, month-to month Purchase of Service contract extension with Aramark Correctional  
56 Services, LLC, to provide commissary, trust accounting, and kiosk services at the CRC  
57 and the Criminal Justice Facility, effective January 1, 2025, through June 30, 2025, at  
58 the latest, or until a new contract begins with a new vendor; and

60 BE IT FURTHER RESOLVED, the aforementioned contract extension will only  
61 be executed after review and approval by the Office of Economic Inclusion, Department  
62 of Administrative Services (DAS), Office of Corporation Counsel, and Risk  
63 Management, DAS.
