#### **REQUEST**

The Superintendent, Milwaukee County Community Reintegration Center (CRC), is requesting authorization to amend the two-year Purchase of Service Contract with three one-year extensions with Trinity Services Group, Inc. (Trinity) in the value of \$485,800 for the provision of food services at the Vel Phillips Youth Detention Center with the Children, Youth and Family Services (CYFS) area for the period of April 1, 2024, to March 31, 2029.

#### BACKGROUND

On June 28, 2023, with support from the Department of Administrative Services -Procurement Division, the CRC issued Request for Proposal RFP-2023-008 for Correctional Food Service Management. The deadline for this RFP was September 1, 2023. Two vendors submitted proposals and an evaluation committee concluded that Trinity had the highest score.

Milwaukee County entered into the contract with Trinity and this contract with Trinity is to provide food services at the Community Reintegration Center, the Criminal Justice

Facility, and the Vel Phillips Youth Detention Center. This contract began on April 1, 2024, and is for two years, with three one-year extensions. The CYFS Youth Detention Center has requested an updated menu, to include an additional snack (sandwich) in the evenings, to serve youth in the detention center. The new menu allows for additional hot food items, a more robust menu and sandwiches as an evening snack. The additional cost per meal is .58, for a total additional contract amount up to \$485,800 over the course of the contract through March 31, 2029. The total amount varies based on the number of kids in the youth detention center and the number of youth served over the course of the contract period. CYFS will be responsible for the additional costs and is covered within their operating budget.

#### RECOMMENDATION

The Superintendent of the Community Reintegration Center respectfully submits this action item to request the authority to amend a two-year Purchase of Service Contract with three one-year extensions with Trinity Services Group, Inc. in the approximate value of \$485,800 for the provision of food services at the Vel Phillips Youth Detention Center for the period of April 1, 2024, to March 31, 2029.
