11 the Director, Department of Health and Human Services (DHHS), is requesting
12 authorization to enter into 2026 purchase of service contracts with community
13 agencies for Housing Services, DHHS; and

14 WHEREAS, the contract recommendations are within the limits of the 2026
15 Adopted Budget; and

16 WHEREAS, the Committee on Health Equity, Human Needs, and Strategic
17 Planning, at its meeting of December 4, 2025, considered File No. 25-761 for
18 informational purposes only, per Section 59.52(31)(d), State Statutes; and

19 WHEREAS, the Committee on Finance, at its meeting of December 11, 2025,
20 recommended adoption of File No. 25-761 (vote 6-0); now, therefore,

21 BE IT RESOLVED, the Director, Department of Health and Human Services
22 (DHHS), or her designee, is authorized to enter into 2026 Housing Services purchase
23 of service contracts, effective January 1, 2026, to December 31, 2026, with the
