

Trinity Food Services Amendment 2, by recommending adoption of the following:

A RESOLUTION

WHEREAS, the Community Reintegration Center (CRC) facilitates the Master Agreement (the Agreement) for Correctional Food Service Management with Trinity Services Group, Inc. (Trinity), for the CRC, the Criminal Justice Facility (CJF), and Vel R. Phillips Youth Detention Center (YDC); and

WHEREAS, Milwaukee County (the County) shall make a single lump-sum payment of \$23,598.65 to Trinity, on or before January 1, 2026, to compensate Trinity for milk or juice cartons supplied to the CRC, CJF, and YDC for security or special-needs units or residents/occupants; and

WHEREAS, the current total of \$590,759.55, with this payment, shall represent the entire amount necessary to reimburse Trinity for milk and juice cartons provided from the effective date of the Agreement through September 30, 2025; and

WHEREAS, the County shall not be held responsible for any additional charges related to the provision of milk or juice cartons prior to October 1, 2025; and

WHEREAS, beginning on October 1, 2025, and continuing throughout the term of this Agreement, unless the Parties otherwise agree in writing, Trinity may charge the County no more than \$0.50 per carton of milk or juice; and

WHEREAS, the per-meal price assumes bulk beverages when sealed containers are required for safety or security, and the County may request milk or juice cartons priced at \$0.50 each, while following the same fee structure for additional whole fresh fruit for pregnant residents when not otherwise required; and

WHEREAS, these charges are itemized, excluded from the 3.5-percent per meal increase, and subject only to approved economic price adjustments; and

WHEREAS, the prior initial term of the Agreement began April 1, 2024, through March 31, 2026, with up to three one-year renewal terms; and

WHEREAS, the initial term of Amendment 2 began March 29, 2024, through December 31, 2026, with the option to renew up to three one-year renewal terms through March 31, 2029, subject to performance and timely written notice; and

WHEREAS, the Committee on Judiciary, Law Enforcement, and General Services, at its meeting of January 27, 2026, considered File No. 26-235 for informational purposes only, per Section 59.52(31)(d), Wisconsin State Statutes; and

51 the Superintendent, Community Reintegration Center, or her designee, to retroactively
52 execute Amendment 2, which includes changes to the Master Agreement and Statements
53 of Work (SOW) 1, SOW 2, and SOW 3, dated October 1, 2025; and

56 approval by the Office of Economic Inclusion, Department of Administrative Services
57 (DAS), the Office of Corporation Counsel, and Risk Management, DAS.
