From the Superintendent, House of Correction requesting authorization to enter into a Professional Service Contract extension with Aramark Correctional Services LLC to extend the term for commissary, trust accounting, and kiosk services for the period of January 1, 2022 to December 31, 2022 to ensure continuity in commissary services while the County’s new kitchen master plan is being developed and implemented, by recommending adoption of the following:

**A RESOLUTION**

WHEREAS, the current commissary and accounting services contract with Aramark Correctional Services, LLC (Aramark), expires on December 31, 2021; and

WHEREAS, a Request for Proposals (RFP) was issued on April 17, 2015, and Aramark was selected as the provider; and

WHEREAS, on December 23, 2015, the Milwaukee County Board of Supervisors (County Board) adopted File No. 15-720, which granted the House of Correction (HOC) the authority to enter into a contract with Aramark for the provision of commissary services at the both the HOC and Criminal Justice Facility (CJF); and

WHEREAS, the terms of the contract approved by the County Board in Adopted File No. 15-720 began January 1, 2016, through December 31, 2018, with an additional two, one-year extensions (2019 and 2020) subject to the approval of the County Board; and

WHEREAS, the County Board adopted File No. 19-362, which approved an additional one-year extension that expires on December 31, 2021; and

WHEREAS, Milwaukee County (the County) has a food service master plan development project underway which is not yet completed for the HOC’s kitchen, and it would be beneficial for any future RFP related to that plan to incorporate the outcome of the master plan; and

WHEREAS, Aramark has agreed to a new, one-year contract extension with the same provisions to help provide continuity in commissary services until the County’s master plan is completed; and

WHEREAS, the Committee on Finance, at its meeting of May 13, 2021, recommended adoption of File No. 21-420 (vote 7-0); now, therefore,

BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby authorizes the Superintendent, House of Correction, to enter into a new, one-year Professional Service Contract extension with Aramark Correctional Services, LLC, to provide commissary and accounting services through December 31, 2022; and
