- A. The EMS Division has been awarded significant funding from the Opioid Settlement Fund project and is now positioned to create a Mobile Integrated Health team focused on chronic and acute disease prevention, providing patients with an upstream engagement in their healthcare.
 - B. Opioid Settlement Funding is covering the entire cost of this position.
 - C. With 6 pay periods remaining after an effective date of 9/28/2025, the 2025 cost is \$64,473.60. This impact would be covered and offset by Opioid Settlement Funds.
