### REQUEST

Retroactive approval to apply for, and accept, the U.S. Small Business Administration Shuttered Venue Operators Grant (SVOG) funds for the Fiscal Year 2021; and to create a new trust fund to recognize grant funds and align expenditure authority per the grant rules and regulations.

### **BACKGROUND**

The Milwaukee County Zoo is one of the top four attractions in Wisconsin and is the largest cultural institution. It annually attracts over 1.2 million visitors. The Zoo has a full-time staff of 135 and has an additional 150 seasonal and hourly staff during its busiest season. It lies on a 192-acre wooded campus and houses 2,213 specimens of 330 species. The Zoo is open every day except Thanksgiving Day, Christmas Day and New Year's Day.

The Zoo was open for regular operations in 2020 through March 14; including February 20, 2020. On March 15, 2020 the Zoo was forced to close to the public under regulations from the State of Wisconsin and local health department, due to the Covid-19 pandemic. The Zoo remained closed until June 13, 2020. This closure not only affected normal visitation, it also disrupted one of the busiest times of the year, the spring break and field trip seasons. Once allowed to reopen in June, attendance capacity was limited to 25%. Public health restrictions remain in place today. Regardless of being open to the public, our animals and facility require daily care and

#### maintenance.

From March 15, 2020 to December 31, 2020 the Zoo lost \$11,480,288 (64%) in earned revenue. The Zoo placed 95% of its staff on decreased work hour furloughs. Since January 2, 2021, the Zoo has been open at reduced hours and follows County Administrative orders as it relates to capacities and pandemic restrictions.

In January 2021, the U.S. Small Business Administration (SBA) released guidance on the Shuttered Venues Operators Grant (SVOG). The SVOG would allow the Zoo to address revenue shortfalls experienced due to closures and capacity reductions. At the time of the release, there was no indication on when the opportunity would go live for applications. Additionally, the Parks Department had indicated their interest in applying for the grant. Over the following months, internal discussions were held with Zoo, Parks and Department of Administrative Services staff to identify how the County could apply for this opportunity. In March 2021 additional guidance was provided to applicants by SBA which limited the dollar amount a single entity could apply for. Given that the Zoo had significantly higher financial losses than the Parks department, it was determined that the Zoo would put forth the SVOG application for Milwaukee County. This decision occurred at the end of March 2021. Shortly after that decision, SBA announced that the application was due on April 8, 2021.

The confluence of no hard deadline for applications and the late notice on applicant guidance prohibited the Zoo's ability to request approval from the Finance Committee and Board of Supervisors prior to the scheduled cycles. Rather than request a special public meeting ahead of the deadline, the Zoo is requesting retroactive authority to apply for, and receive, the 2021 SVOG and to hold the public hearing and review for the application during the regular September 2021 cycle meeting.

In order to mitigate the risk of losing grant funding, the Zoo submitted the grant application on April 8, 2021. Then, the public hearing and review of the application will occur at the Finance Committee on September 16, 2021.

The total SVOG allocation to the Zoo is for \$6,849,482.40 to offset the Zoo's net deficit in 2020 and any potential deficit in 2021.

### ALIGNMENT TO STRATEGIC PLAN

3B: Enhance the County's fiscal health and sustainability

#### FISCAL EFFECT

The SVOG does not require a local match. The funds, which are forwarded to the County and pursuant to grant guidelines, must be held in a separate non-interest-bearing trust account.

In order to shore up revenue loss sustained by the Zoo as a direct result from the COVID-19 pandemic, it is recommended that the Zoo be retroactively authorized to apply for and accept SVOG funds. In addition, the Comptroller's Office in conjunction

with the DAS-PSB and the Zoo are directed to establish a new trust fund and have administrative authority to recognize the revenue and align expenditure authority per the grant rules to benefit the Milwaukee County Zoo.

## **TERMS**

The "Budget Period" for the grant covers March 1, 2020 through December 31, 2021.
