## DESCRIPTION OF FISCAL EFFECT

A. Briefly describe the nature of the action that is being requested or proposed, and the new or changed conditions that would occur if the request or proposal were adopted.

The Register of Deeds requests approval to execute a contract consisting of a Master Services Agreement, three (3) Statements of Work (one for each contracted service) and a Bulk User Agreement for Monarch Data Distribution Services (collectively, the "contract"). The approval of the requested action will allow Milwaukee County to execute a five-year (with optional four (4) one (1) year renewals) land records and cashiering contract for total fees not to exceed \$392,225 with Fidlar Technologies, Inc. Since 2020, the Register of Deeds has contracted with Fidlar Technologies on a year-to-year basis and most recently on a month-to-month basis during the Request for Proposal process. Fidlar Technologies, Inc. was the successful candidate. This contract will ensure continuity of services and allow the Milwaukee County Register of Deeds to continue its statutory obligations pursuant to Wis. Stat., Sec. 59.43 to record, archive and make searchable real estate documents and make available vital records to the public pursuant to Wis. Stat., Sec. 69.20.

B. State the direct costs, savings or anticipated revenues associated with the requested or proposed action in the current budget year and how those were calculated. <sup>1</sup> If annualized or subsequent year fiscal impacts are substantially different from current year impacts, then those shall be stated as well. The overall cost under this five (5) year Fidlar Technology, Inc. contract will be \$392,225. This amount reflects the five-year cost of the contract of \$542,225 minus a discount of \$150,000. The total revenues expected are approximately \$3,481,205. The yearly revenues are estimated at:

The Register of Deeds and DAS-IMSD Contract Manager negotiated the services, support, costs and license fees for Fidlar Technology, Inc. products. As a result of these negotiations, Milwaukee County is saving \$150,000 over the five (5) year term of this contract and has secured a guarantee of revenue in the minimum amount of \$650,000.00 annually.

This total amount of \$392,225 is expected to be paid from the DAS-IMSD (Central Spend) operating budget for the Fiscal Years 2023 – 2027.

the costs/savings for each of the five years in question). Otherwise, impacts associated with the existing and subsequent budget years should be cited.

There will be no impact to the 2022 budget. For 2023 operating budget, the Register of Deeds budgeted sufficient funds for to pay for Year 1 fees under this Fidlar Technologies, Inc. contract. (DAS-IMSD, low org 1173, has budgeted \$78,445 to pay for year one fees.). These funds are sufficient to fully pay year one fees under the contract.

This Fidlar Technologies, Inc. contract provides excellent pricing, simplified licensing management, and flexibility needed to meet the day-to-day technology needs for the Milwaukee County Register of Deeds Office.

D. Describe any assumptions or interpretations that were utilized to provide the information on this form.

The only assumption or interpretations used by the Register of Deeds Office for the software products to be licensed under the Fildar Technologies, Inc. contract are based on Milwaukee County's historical data on usage and revenues paid by existing users.
