





Distinguish colleagues, I must inform you and give you notice that this item is improperly being heard in this committee it must be heard in the Judiciary Committee. This Committee does not have the policy making and rule making powers to take action on this item.

According to Wisconsin State Chapter 323.14 Sub 1 Sub A Sub 3 it states that

3. Each county board shall designate a committee of the board as a county emergency management committee. The chairperson of the county board shall designate the chairperson of the committee. In counties having a county executive under s. 59.17, the committee shall retain policy-making and rule-making powers in the

establishment and development of county emergency management plans and programs.

Furthermore, Milwaukee Code of Ordinance Chapter 99.03 which is our policy for the rule making committee mandated by the state under the previous statutes I made mentioned states.

The committee on judiciary, safety and general services of the county board is established as the standing committee of the county board that shall retain policy-making and rule-making powers in the establishment and development of county emergency management plans and programs under ch. 323, Wis. Stats.

According to a recently received email from Maggie Daun, Corp Counsel she stated, and I quote, "I apologize, I need to make a small correction: chapter 99.03 in its current form mandates that the Judiciary committee is the correct committee to take action on emergency and related orders issued by the CEX. I will advise the Chairwoman of this separately. "

As your colleague and the Vice Chair of the Judiciary Committee I am requesting that we follow what the State Statutes mandate and what our Code of Ordinances Mandates. That item and all mandated under States must be heard in Judiciary.
