

COMMISSION ON AGING EXECUTIVE COMMITTEE MEETING NOVEMBER 29, 2023

MINUTES

I. CALL TO ORDER AND ROLL

Chair Janice Wilberg called the meeting to order at 9 a.m. Secretary Moore called the roll. A quorum was present.

II. DISCUSSION AND ACTION ITEMS

Chair Wilberg informed the Executive Committee of the primary purpose of today's meeting: to discuss and plan the 2024 County Budget allocation increase of \$270,000 for the Area Agency on Aging before the end of the year.

Aging Director Daniel Idzikowski requested to amend the agenda to include an action item to send a letter to the Wisconsin Department of Transportation to support State allocation to Milwaukee County for 85.21 Specialized Transportation Funding.

MOTION: To amend the agenda to include an action item for the approval to send a letter to the Wisconsin Department of Transportation.

ACTION: Motion prevailed by unanimous consent (Moeser Moved, A. Miller Second).

A. Action Item, Allocation of the 2024 County Budget increase \$270,000 for Aging Services: Director Idzikowski provided background information on the original motion made by the Advocacy Committee to request a supplemental budget request for \$170,000, which the Commission on Aging

adopted. The Advocacy Committee had to determine which areas the funding would be needed, and they passed a resolution that included the breakdown of the budget funding allocations:

- > Caregiving \$50,000
- > Ombudsmen \$50,000
- > Senior Centers \$30,000
- > Transit \$20,000
- ➤ Food Security- \$20,000

Matt Fortman, Chief Financial Officer for Milwaukee County DHHS incorporated the \$170,000 into a supplemental budget request to the County Executive, which the Executive staff accepted as a one-time-only request.

The COA then asked CFO Fortman to see if the budget request could be a continuing budget item, to which the answer was no. Then, in September, the Advocacy Committee recommended the Commission request an additional \$100,000 to the original request passed by the Commission. Chair Wilberg presented that motion at the County budget hearing, which passed.

After a lengthy discussion, the Executive Committee recommends that the Commission should reallocate the \$270,000 in additional County Levy funding as follows:

MOTION: To approve the allocation of \$270,000 in additional County Tax Levy funding as follows:

SAGE/LGBT Long Term Care Training Project: \$30,000

Senior Centers: \$75,000
Transportation: \$75,000
Food Security: \$75,000
Wellness: \$15,000

ACTION: Motion prevailed by unanimous consent (Moeser Moved, A. Miller Second).

Chair Wilberg requested that this recommendation be added to the agenda for the December COA meeting to read as follows: Funding Allocation Recommendation from the Executive Committee.

B. Action Item, Letter to the Wisconsin Department of Transportation

MOTION: To send a letter to the Wisconsin Department of Transportation supporting the State allocation to Milwaukee County for 85.21 Specialized Transportation Funding.
