3 Report from the Director, Department of Health and Human Services, requesting
4 authorization to execute non-professional service contracts with caterers supporting
5 the Senior Congregate Dining Program and minority owned restaurants preparing
6 meals for the Dine-Out Program for a total of \$2,992,000, by recommending
7 adoption of the following:

9 **A RESOLUTION**

11 WHEREAS, the Division on Aging (Aging), Department of Health and Human
12 Services (DHHS), administers the Milwaukee County Senior Meal Program, which
13 brings delicious, nutritious meals to older adults; and

14
15 WHEREAS, Title III-C of the Older Americans Act provides funding for
16 programs that reduce hunger and food insecurity, promote the socialization of older
17 adults, and promote the health and well-being of older adults by assisting them to
18 access nutrition and other disease prevention and health promotion services to
19 delay the onset of adverse health conditions; and

20
21 WHEREAS, Aging, DHHS, as an expansion to its existing Meals on Wheels
22 and congregate dining programs, piloted the Dine Out Program (the Program)
23 beginning in April 2021 during the Coronavirus Disease pandemic, partnering with
24 four local minority-owned restaurants, and a new meal-site supervisor; and

26 WHEREAS, the Program has served over 4,000 meals from the end of April
27 through September, while expanding the dietary appeal of older adult meal
28 programming by offering more ethnically diverse meal choices; and

29
30 WHEREAS, the congregate dining programs provide the majority of meals to
31 older adult diners, and these caterers are on pace to prepare over half a million
32 meals to be distributed at congregate dining sites in 2021; and

34 WHEREAS, the Committee on Finance, at its meeting of December 9, 2021,
35 recommended adoption of File No. 21-1026 (vote 7-0); now, therefore,

37 BE IT RESOLVED, the Milwaukee County Board of Supervisors hereby
38 authorizes the Director, Department of Health and Human Services, to execute 2022
39 non-Professional Service Contracts, for the period beginning January 1, 2022,
40 through December 31, 2022, with the providers and for the terms as listed below for
41 a total cost not-to-exceed \$2,992,000:
